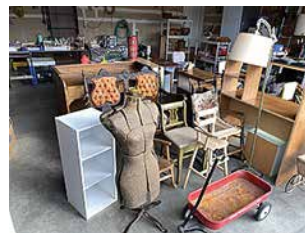

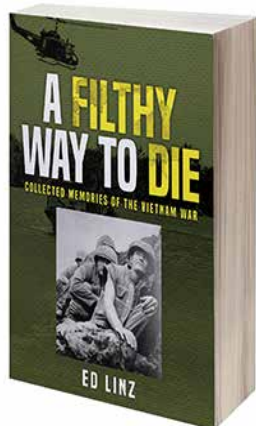

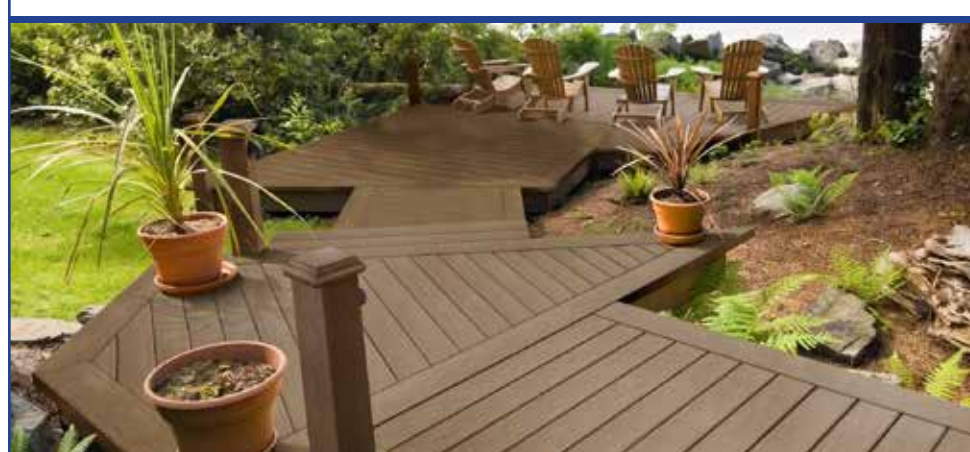

SPOKANE VALLEY CITY COUNCIL | TUESDAY, SEPTEMBER 15, 2026 | MEETING RECAP

This week's Spokane Valley City Council meeting began with the pledge of allegiance and approval of the following meeting agenda. Councilmember Yaeger was excused from the meeting.

PROCLAMATION

Mayor Padden presented a proclamation for America 250 Constitution Week to members of the Daughters of the American Revolution.

General Public Comments

Each week, community members have an opportunity to address Councilmembers for up to three minutes during the General Public Comment period, either at the beginning or end of each meeting, either in person or via Zoom.

ACTION ITEMS

#1 – Public Hearing – 2027 Budget Revenues, Including Property Tax

The 2027 budget is currently under development; this is the first of three public hearings and third of eight discussions by the Council before they are asked to approve the budget on Nov. 17, 2026. Staff shared information on sales tax revenue estimates, property tax revenue estimates, capital expenditures, recurring and non-recurring expenditures, major revenues for the general fund and other funds, and funding challenges. Members of the public were invited to share their thoughts and provide input regarding the city budget.

NON-ACTION ITEMS

#2 – Right-of-Way Vegetation Control Discussion

Staff provided a summary of ongoing vegetation maintenance within the city's rights-of-way (ROW). Typical ROW maintenance includes dryland grass moving, weed control, addressing vegetation obstructions (such as overgrown bushes or trees blocking line-of-sight), tree removal, and tree trimming. Staff provided information from 2016 to 2026 on the maintenance

contractors, costs, responses to community requests for service, and plans for this program going forward.

#3 – 2027 Council Goals and Priorities for Lodging Tax Advisory Committee (LTAC)

Council goals and priorities for using lodging tax revenues to benefit tourism in Spokane Valley were last reviewed by Council in July 2025. Per SVMC 3.20.010, the City collects a 3.3% tax on lodging (hotel/motel room rentals) within Spokane Valley. Staff outlined Washington state regulations for the allowed uses of collected lodging tax. Staff provided details about the lodging tax, outlined the state rules regarding use of the lodging tax, and the types of organizations/projects that may be awarded funds from the tax revenue. While the city's Lodging Tax Advisory Committee (LTAC) evaluates and recommends which organizations/projects receive the tax proceeds, the City Council makes the final decision. The Council reviewed and discussed potential recommendations to update the proposed 2027 goals.

The Council reached consensus on the 2027 goals and priorities to be considered by the LTAC when evaluating applications. This item is scheduled to come before Council as a motion consideration at the Sept. 22, 2026, meeting.

#4 – 2026 Justice Assistance Grant (JAG)

The Department of Justice annually awards JAG grants to local jurisdictions nationwide for various criminal justice purposes. This year, the City will receive \$30,978 in JAG funds. The Spokane Valley Police Chief has recommended utilizing the grant allocation towards the purchase of a new motorcycle. The total cost for a motorcycle is \$43,470. The approximate \$12,500 cost difference will be covered by the SVPD Traffic Designated Unreserved Fund from DUI restitution. By using JAG and SVPD monies, the City will not need to fund the purchase of a motorcycle in 2028.

The Council reached consensus for staff to return with a motion consideration at a future meeting to apply for and use JAG funds to purchase a SVPD traffic motorcycle.

#5 – Draft Comprehensive Plan Periodic Update

The Council has reviewed and discussed the draft Comprehensive Plan update multiple times since the update process began in January 2025. The draft plan has been updated to incorporate suggested changes, further edited for clarity and accuracy. The draft document is available on the city website for review by the public at www.SpokaneValleyWA.gov/Valley2046.

The Council will be presented with the final draft Comprehensive Plan and Development Regulations on Nov. 17, 2026, there will be a public hearing on Dec. 1, 2026, and the Council will be asked to approve the updated plan at the Dec. 15, 2026, meeting.

We got a good amount of rain in Leavenworth over the weekend. I am sure this is a good thing for the fires that are still burning in the region and hope it doesn't result in flooding in certain areas. I was on the road a few days last week, and I am planning some day trips to check on a couple of fishing opportunities that come along in the fall.

I traveled to Hayden, Idaho last week to attend a special event on behalf of Mark's Marine with the Thunder Jet, and to explore a couple of the lakes in the area. Although the fishing for big kokanee on Lake Coeur d'Alene is still going great guns, I wanted to fish Hayden Lake for the first time. My fishing buddy, Tony Johnson, told me about the terrific fishing for kokanee on Coeur d'Alene, but agreed to take me to Hayden in his Thunder Jet Luxor. He said that the size of the kokanee on the lake were almost as big as the ones on Coeur d'Alene, but the good fishing for them may be over. He was sure right. It was not only over, the kokanee seemed to have all but disappeared. We saw a couple of good marks when we left the Honeysuckle Park launch, and then they became scarce. Not only that, but the wind also came up. We battled the wind and searched a couple of different areas of the lake and simply couldn't find any fish. Even when the wind settled down the screen remained blank. Kokanee aren't the only species found in Hayden, there is a long list of other fish attractive to anglers, but we only had our kokanee gear along. Well, lesson learned—hit Hayden in the spring and early summer for kokanee.

My new fishing buddy, Tony Johnson, wants to troll for the big rainbow on Lake Pend Oreille, on his Thunder Jet. Pend Oreille is kind of intimidating. It's 43 miles long and over 1,000 feet deep. I see people using everything from kokanee gear to big plugs or flies. Right now, the big rainbow, and I mean fish over 20 pounds, are down deep. As the water cools they move up in the water column and in the early winter peo-

ple flat line their lures. I took my box of lures that I use for the big cutthroat on Omak Lake.

We launched Tony Johnson's Thunder Jet Luxor near the bottom end of Lake Pend Oreille in Farragut Boat Launch last Friday and was pleased to see Joe Cimino had joined us for the day. We headed across the lake, above the slides where mountain goats are often seen, to the Concrete Plant. There is no limit on the number of rods you can have out on Pend Oreille and we had them stacked on the riggers and run out the back on cannon ball weights. We had a variety of plugs on our



lines and changed them often. We were watching the Lowrance and seeing lots of marks that were schools of kokanee up high and much larger marks down to 80 feet. Our hopes were to hook one of the monster rainbow that inhabit Pend Oreille. Fishing for these trophies is best in October and November, but it never hurts to learn your way around this huge patch of water. They pointed out different landmarks and trolled up to Whiskey Rock to within sight of Maiden Rock before turning back to the launch. It was a beautiful day to be on the water, and we vowed to come back when the big rainbow are biting. This week's photo is of Tony's Thunder Jet at the Farragut boat launch.

call gyotaku. The portable aquarium will also return this year, where visitors can spot and name local fish. Families can also visit a Native American village and learn about the traditions, stories and cultures of indigenous people from across the region. The experience will feature 45 Native American educators and exhibitors representing 11 tribes and bands.

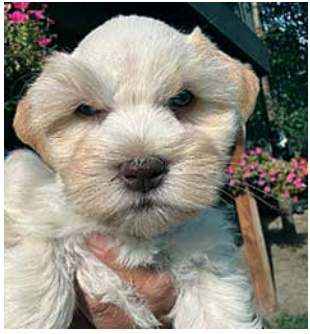

TERMS & ACRONYMS IN REAL ESTATE



Have you ever met with a real estate agent or gone through the entire buying or selling process and heard terms or acronyms that you did not understand? We try to be as clear as possible in our communication throughout the buying and selling process. However, we may use some terms that we use all the time and don't realize may not be as clear to others as we think. Here is a list of common real estate terms and acronyms that you might hear:

"FSBO" - For Sale By Owner. When a seller is selling but has not hired a real estate brokerage and is doing it themselves.

"CMA" - Comparative Market Analysis. A report a real estate broker provides to a seller that shows the broker's opinion of value, using comparable properties that have recently sold to help form that opinion.

"Inspection" - Buyers are advised to hire a home inspector to conduct a home inspection. This involves a thorough look at a home so the buyer has a more complete understanding of the condition of the home. This should not be confused with an appraisal.

"Appraisal" - If there will be a loan on the property, the lender will hire an appraiser to inspect the property and determine its value and condition to ensure that it will be sufficient collateral for the loan.

"MLS" - Multiple Listing Service. Agents who belong to a real estate association or MLS have agreed to cooperate and upload their listings to this database.

"Contingency" - In a contract to purchase real estate, a contingency is something that must happen or be satisfied for the sale to continue. For example, a home inspection, financing, or well and septic tests may be contingencies.

"Feasibility" - This is a contingency in a contract that allows the prospective buyer to conduct due diligence on the property and verify its usability for the buyer's intended use.

"CC&R" - Covenants, Conditions, and Restrictions are legally binding rules found in planned communities and subdivisions. They govern how homeowners may use and maintain their homes and properties and often work in conjunction with homeowners associations.

"REALTOR®" - A trademarked name used by real estate professionals who are members of the National Association of REALTORS®.

"REO" - Real Estate Owned. Property that is owned by a lender, such as a bank or government agency, typically after a foreclosure when the property has not been sold at auction.
